KEY POLICY GOALS FOR ACA IMPLEMENTATION

- Securing Medicaid benefits in all states for those earning ≤138% FPL
- Reaching vulnerable populations, enrolling them into coverage and engaging them in services
- Including Medicaid-focused information in education/outreach materials related to the ACA
- Ensuring Medicaid-eligible applicants receive effective assistance from Navigators and other assisters
- Limiting out-of-pocket costs for prescription drugs, outpatient services, ED visits, etc., which serve as a dis-incentive to enroll in Medicaid and engage in services
- Building MCO relationships and provider networks able/willing to serve high-needs, homeless individuals
- Ensuring comprehensive service packages (e.g., adding adult dental & vision, case management, etc.)
- Ensuring all states suspend, rather than terminate, Medicaid benefits for incarcerated and/or institutionalized populations (thus aiding enrollment, continuity of care and re-entry processes)
- Continuing to provide services to those remaining uninsured

Outreach trainings: National HCH Council regional trainings and conferences include workshops targeting frontline workers that review best practices, share lessons learned, and exchange strategies for engaging people who are homeless into both benefits and services. Trainings frequently include a focus on roles such as Community Health Workers and peer advocates, as well as enrollment assisters, clinicians and other workers. Consumer-focused Research on Outreach (July 2012): "Within Reach: Perspectives of Hard to Reach Consumers Experiencing Homelessness—Findings from a Consumer Participation Outreach Survey": A 10-city survey of consumers that identifies experiences with and attitudes toward outreach workers, the factors that make for an effective/ineffective outreach worker, and the experiences with health insurance enrollment and benefits application process (what works and what doesn't work). These findings should help tailor local outreach approaches to more vulnerable populations living on the street.

<u>National Outreach Guidelines for Underserved Populations</u> (2012): Developed through a collaboration of five national partner organizations: The Association of Community Health Centers (NACHC), the National Health Care for the Homeless Council (NHCHC), the Association of Asian Pacific Community Health Organizations (AAPCHO), Migrant Health Promotion (MHP) and the Health Outreach Partners (HOP). This is a framework containing strategies for outreach tailored to programs, communities, and client-focused services.
