- 2023: Over >650 anti-LGBTQ bills across 46 states
  - Goal is to remove LGBTQ+ people from society
  - Many target transgender youth


## Implementing the Agenda



- Prohibit, penalize or criminalize the provision of genderaffirming care
- Define gender-affirming care as "child abuse"
- Prohibit updating government-issued identification
- Prohibit discussions of sexual orientation or gender identity
- Ban books with LGBTQ+ topics
- Prohibit use of pronouns
- Require teachers to out children
- Bar participation in athletics
- Reimpose a ban on transgender military service (Federal)
- Create non-evidence-based standard of care for accessing gender-affirming care (Missouri) (ACLU, 2023; Translegislation.com, 2023)



## Fueled by a toxic mix of

- Partisan politics
- Religiosity
- Non-evidence based policies and decisions

## **Unconscious Bias**

- Bias is normal and a survival mechanism
- Acts as a filter to help process the onslaught of information
- Product of culture, identity, and experience
- Influenced by social media, popular culture, law, governmental action/policy, family, faith groups, peers



## Cisheteronormativity



 A pervasive system of belief that centers and naturalizes heterosexuality and a binary system of assigned sex/gender when there are two rigid, distinct ways of being: assigned-male-at-birth masculine men and assigned-female-at-birth feminine women.


## Religiosity and Politics: Impact on Health Policy



- Conscious partisan tactic to motivate base of the Republican Party
  - GOP State Resolutions / Platforms (KS, TX)
    - "...oppose all efforts to validate transgender identity."

(Shorman & Woodall, 2018; Texas GOP, 2022, p.21) )

- Alignment of "Christian" hate groups (SPLC, n.d.) with GOP
  - Family Research Council
  - American College of Pediatricians
  - Alliance Defending Freedom
  - Liberty Counsel
- "Religious Liberty" being used as a weapon to discriminate against LGBTQ+ people broadly, transgender people specifically



## In their own words . . .



#### (Homosexuality and Gender Issues)

**143.** <u>Homosexuality</u>: Homosexuality is an abnormal lifestyle choice. We believe there should be no granting of special legal entitlements or creation of special status for homosexual behavior, regardless of state of origin, and we oppose any criminal or civil penalties against those who oppose homosexuality out of faith, conviction, or belief in traditional values. No one should be granted special legal status based on their LGBTQ+ identification.

**144.** <u>Gender Identity</u>: We oppose all efforts to validate transgender identity. For the purpose of attempting to affirm a person age 21 or under if their perception is inconsistent with their biological sex, no medical practitioner or provider may engage in the following practices:

- a. Intervene in any way to prevent natural progression of puberty.
- b. Administer or provide opposite sex hormones.
- c. Perform any surgery on healthy body parts of the underage person.

**145.** <u>No Taxpayer Funding for Sex Change</u>: We oppose the use of taxpayer funds for any type of medical gender dysphoria treatments or sex change operations and/or treatments. This includes but is not limited to military personnel as well as inmates in federal, state, or local prisons or jails. Inmates must be housed according to their biological sex. No Federal, state, insurance, or probate monies may be allocated for the use of such treatment.

**146.** <u>Counseling Methods</u>: Therapists, psychologists, and counselors licensed with the State of Texas shall not be forbidden or penalized by any licensing board for practicing Reintegrative Therapy or other counseling methods when counseling clients of any age with gender dysphoria or unwanted same-sex attraction.

**206.** <u>Gender Identity</u>: We support enacting legislation in the State of Texas ensuring that:

- a. No government entity in the state shall be allowed to take it upon itself to define for any private business or private entity how it must segregate its restrooms, changing facilities, or showers.
- b. Nor may any government agency be allowed to require businesses to profess, espouse, or adopt specific views on sex, sexuality, gender, or gender identity. We oppose any attempt to criminalize and/or penalize anyone for the wrong use of pronouns.
- c. Government agencies must guarantee that views and positions on these matters are not used as a basis to deny access to public accommodations, as defined by the Civil Rights Act of 1964, nor to deny employment, or discriminate in employment decisions, solely on the basis of a person's views on these matters.
- d. We recognize that gender identity disorder is a genuine and extremely rare mental health condition and that denial of an immutable gender binary not only denies those with the condition proper mental healthcare but also leads to physically and psychologically abusive "social transitioning" as well as irreversible physical mutilation. We urge the State Legislature to pass legislation that requires adherence to sex identifications on all official documents that will be based upon biological gender, as well as legislation enacting civil penalties and fiscal compensation awarded to de-transitioners who have received "gender affirming surgery" as compensation for malpractice.

#### (Family and Gender Issues)

**207.** <u>Human Sexuality</u>: We affirm God's biblical design for marriage and sexual behavior between one biological man and one biological woman, which has proven to be the foundation for all great nations in Western civilization. We oppose homosexual marriage, regardless of state of origin. We urge the Texas Legislature to pass religious liberty protections for individuals, businesses, and government officials who believe marriage is between one man and one woman. We oppose the granting of special legal entitlements or creation of special status for sexual behavior or identity, regardless of state of origin. We oppose any criminal or civil penalties against those who oppose non-traditional sexual behavior out of faith, conviction, or belief in traditional values.

**208.** <u>Protect Minors Until Age of Consent</u>: A law should be enacted to protect the rights of the individual until the age of consent is reached.</u>

- a. Prohibit sexual transition surgeries, hormonal blockers, social transitioning, or other treatments
- b. Protect against predatory sexual behaviors, including but not limited to "Drag Queen Story Hour"
- c. Remove immunities or protections from school districts and personnel which participate in the sexualization of our children
- d. Require disclosure of the above offenses to parents or guardians

**209.** <u>Definition of Marriage</u>: We support the definition of marriage as a God-ordained, legal, and moral covenant only between one biological man and one biological woman.

## It was NEVER About Bathroom Safety

"Our side concocted the "bathroom safety" male predator argument as a way to avoid an uncomfortable battle over LGBT ideology, and still fire up people's emotions. It worked in Houston a few years ago." (Mass Resistance, 2018)





## Impact on LGTQ+ Youth



- LGBTQ+ youth are at risk
  - 45% suicidal ideation within last year
  - 73% report discrimination
  - <33% home was gender affirming</p>
  - 60% could not access mental health care

(The Trevor Project, 2022a)

 86% of transgender and Nonbinary youth have had a negative mental health impact from the debates 45% have been victims of cyberbullying (The Trevor Project, 2023)







Identify actions that individual practitioners can take to be advocates and allies to TGD people

## What Can I do?



- Language Matters
  - Use the patient's chosen/affirmed name and pronouns
  - Use culturally-aware terminology
  - Mirror the language the patient uses to describe themselves / their anatomy
- Actions Matter
  - Do not exhibit "Transgender Broken Arm" syndrome
  - Practice gender-affirming care
    - Meet the patient where they are at in their journey
      - Whatever the patient's gender identity happens to be is OK
    - Practice trauma-informed care (Examinations, procedures, questioning)

## Transgender Broken Arm Syndrome



"Trans Broken Arm Syndrome typically stems from a failure by health professionals to recognize that trans patients have the same general health needs as any of the rest of us; that their health is not purely defined by their trans status" (Graham, 2021) How this plays out in practice:

- Clinician's reflexive loss of general competence when the patient is identified as transgender
- Inordinate focus on patient's status of being transgender / transition (genitals)
- Blaming hormones as cause for all presenting complaints (Brice, 2020; Graham, 2021; Neira & Bowman, 2022)

## Advocate for Organizational Change



- Insurance (Payor/Payee mix)
- Ownership / Affiliation
- Staff Training / Education
  - Formal training remains lacking in most school curricula
  - Online education free and accessible
- Facilities
  - Signage
  - Gender-neutral bathrooms
- Forms & Policies
  - Language and Options
- Electronic Medical Records
  - Legal Name / Chosen Name / Pronouns to use
  - Gender Markers
  - System Interface Issues / Reference Ranges (Lab)
  - Sexual Orientation & Gender Identity (SOGI)



## **Be an Ally / Advocate**



- Look Inside what are your blind spots? What is your learning curve?
- Listen to your TGD community and staff members
- Learn Seek out knowledge from reputable sources / experts
- Lead Speak Up! Speak Out! Set the example!
  - Avoid performative allyship
  - No tolerance for willful ignorance, intentional misrepresentation, prejudice, harassment, bigotry
  - Do not let the lies/ false narratives/ gaslighting go unchallenged
  - Engage your circle of influence
